That I, C. M. Jones, - - - - - in the State aforesaid, in consideration of the sum of One Dollar and division of real estate, - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, T. G. Jones, his Heirs and Assigns forever, ALL of my right, title and interest in and to ALL that certain piece, parcel or tract of land situate, lying and being in the State and County aforesaid, Chick Springs Township, near Reid's School house, lying on the south side of Buck Horn Creek and on both sides of the Reid's school Road, and being shown on a Plat of J. M. Jones Estate as tract No. 2, said plat made by W. A. Hester, Surveyor, January 3rd 1922, and having the following courses and distances, to wit:-

Beginning on an iron pin in the said road, joint corner of tract No. 1, and runs thence with the line of tract No. 1, N. 6 1/2 E. 44.50 chs. to a Wild Cherry Tree, n.m., on south bank of Buck Horn Creek; thence up and with the meanderings of said creek to a stone corner, o.m., on south bank of creek; thence S. 73 1/2 W. 1.90 chs. to a stone corner, o.m.; thence S. 59 W. 10.75 chs. to a stone corner, o.m.; thence S. 4 E. 42.80 chs. to an iron pin in said road; thence with said road, S. 74-00 W. 4.97 chs. to an iron pin, S. O. gone; thence S. 75 1/2 E. 13.15 chs. to an iron pin, o. m.; thence N. 39 1/2 E. 2.55 chs. to an iron pin, o. m.; thence N. 60 1/2 E. 4.70 chs. to an iron pin, n. m.; thence N. 41 1/2 W. 4.20 chs. to an iron pin in the said Reid's School Road; thence with the said road, N. 83 W. 72 links to the beginning corner, containing Seventy Five and No/100 (75) acres, more or less.
