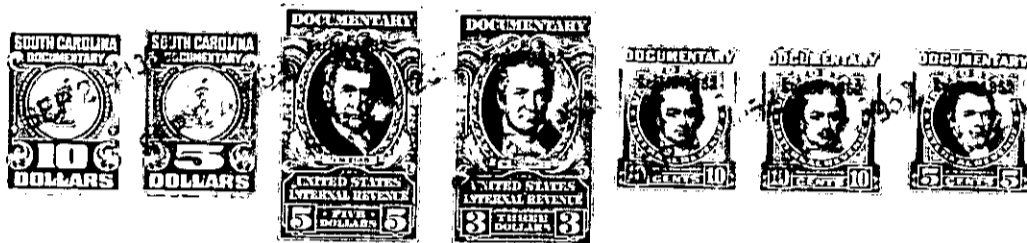

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Monroe Norwood, his heirs and assigns, all that piece, parcel or lot of land, situate, lying and being on the West side of West Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 16, of the Property of J. R. West, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book D, page 68, and having, according to said plat, the following metes and bounds, to wit:
