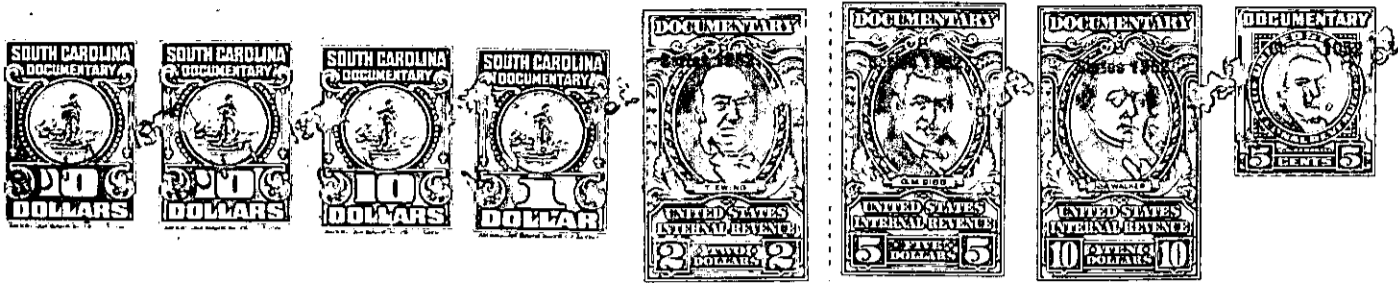

herein called grantor.....

in the State aforesaid, in consideration of the sum of Fifteen-thousand twenty-seven
and 63/100 (\$15,027.63).....Dollars

to..... me..... in hand paid at and before the sealing of these presents
by Grace M. Hindman, herein called grantee.....

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said... grantee.....

all that piece, parcel or lot of land in Greenville Township, Greenville
County, State of South Carolina;

1. All that lot located on the Lowndes Hill Road which was deeded to
me by J. P. Jamison, June 16, 1951, by deed recorded in Book 436 at
Page 490, to which reference is made for a more complete description.
The consideration for this deed is the sum of \$2400.00, the lot being
deeded subject to an outstanding mortgage to Franklin National Life
Ins. Company, the balance of which is approximately \$2100.00, but this
mortgage is not assumed by the grantee.

2. Lot No. 2, Block G, of Park Place, shown on plat recorded in Book A,
Page 119, and being the same property conveyed to me by Ruth M. Cook,
April 6, 1951, by deed recorded in Book 432 at Page 293, to which
reference is made for a more complete description. The consideration
for this lot is \$2200.00 and this deed is made subject to a mortgage
held by the First Federal Savings & Loan Association, the balance due
being approximately \$2750.00, but the mortgage is not assumed by the
grantee.

3. That lot located in the southeastern intersection of Fourth Avenue
and "B" Street fully shown on plat of Village Homes of F. W. Poe
Manufacturing Company, recorded in Book Y at Page 25. This being the
same lot deeded to me by Elbert P. and Velma M. Bradshaw, May 30, 1951,
by deed recorded in Book 435 at Page 428, to which reference is made for
a more complete description. The consideration for this deed is \$1150.00
and this deed is made subject to a mortgage held by General Mortgage Co.
on which the balance due is approximately \$2200.00, but the mortgage is
not assumed by the grantee.

4. Lot 17, 9th Street, shown on plat of subdivision of Woodside Mills,
recorded in Book W, Pages 111 to 117. This being the same lot conveyed
to me by Thomas B. and Mary B. Moore, May 28, 1951, by deed recorded
in Book 436 at Page 33. The consideration for this deed is \$1400.00
and the deed is made subject to a mortgage to General Mortgage Company
on which the balance due is approximately \$2100.00, the mortgage is not
assumed by the grantee.

5. Also, Lot 2, Block C, as shown on plat of Judson Mill Village No. 2,
recorded in Plat Book K, Pages 1 and 2. This being the lot conveyed to
