to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named. (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Ethel Lee W. Bruce, her heirs and assigns, forever.

All that parcel or strip of land situate, lying and being on the southeast side of Woodland Way, in the City of Greenville, in Greenville County, S. C., and having, according to a survey made by J. L. Jones, Engineer, September 24, 1952, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Woodland Way, at the southwest corner of property of the grantee and running along the line of other property of the grantee, S. 89-24 W. 20 feet to an iron pin; thence continuing along line of property of the grantee, along a curved line (the chord being S. 89-28 W. 50 feet) to an iron pin on the northwest side of Hemlock Drive; thence along the north side of Hemlock Drive, (the chord being S. 53-41 W. 33 feet) to an iron pin; thence N. 55-23 W. 128 feet to an iron pin; thence N. 87-13 W. 128 feet to an iron pin on the southeast side of Woodland Way; thence with the southeast side of Woodland Way, N. 48-27 W. 3.5 feet to the beginning corner.

This strip of land is shown on a plat of property of the grantee, recorded in the R.A.C. Office for Greenville County, S. C., in Book "I", Page 101, as a portion of a 20 foot drive leading from Woodland Way to Hemlock Drive. The other owners of the property on either side of Hemlock Drive have consented to the closing and widening of this 20 foot Drive. Therefore, the grantor is conveying to the grantee the said drive to the grantee and hereby consents to the closing and abandonment thereof.
