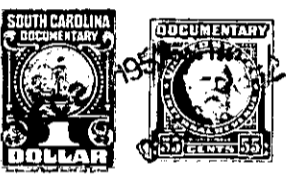
That we, Ben G. Mayfield and Sarah Mayfield, as Executors in the State aforesaid,

All that piece parcel or lot of land near Simpsonville, S. C., known as lots 8, 9, 10 and 11 on a plat of property made for the D. N. Mayfield Estate by J. C. Bruce Eng. Nov. 4, 1952, and recorded in Greenville County R. T. C. office in plat book CC page 199, and having the following notes and bounds according to said plat.

Beginning at a stake at the corner of lot 7 and running S. 21-05 E., 280 feet to a stake at the corner of lot 12; thence S. 68-55 W., 200 feet to a stake on the line of lot 27; thence N. 21-05 W., 280 feet to a stake at the corner of lot 7; thence N. 68-55 E., 200 feet along the line of lot 7 to the beginning corner.

- The above property is conveyed on condition and subject to the following.
1. That no house or other building shall be erected any closer than 40 feet to the road or street on which the property fronts.
 2. That no junk yards shall be placed on the property, nor any alcoholic beverages sold thereon.
