in consideration of the sum of Ninety-Seven Hundred and no/100 (\$9,700.00) in the State aforesaid, DOLLARS,

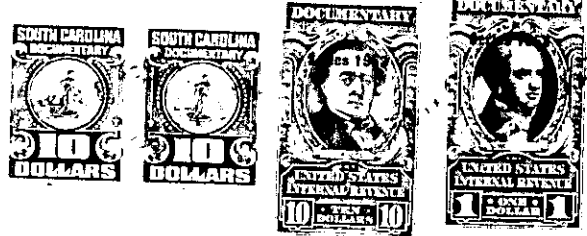

Bailey, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southeasterly side of Dale Drive, in the City of Greenville, S. C., being shown as Lot No. 17 on the plat of the property of E. Godfrey Webster, as recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "Z", page 141, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Dale Drive, at a point 284 feet Southwest of the Southerly intersection of Dale Drive and Ellison Street, said pin being the joint front corner of Lots Nos. 16 and 17, and running thence along the Southeasterly side of Dale Drive S 44-15 W 71 feet to an iron pin, joint front corner of Lots Nos. 17 and 18; thence along the joint line of Lots Nos. 17 and 18 S 55-30 E 219.8 feet to an iron pin; thence N 34-30 E 70 feet to an iron pin, joint rear corner of Lots Nos. 16 and 17; thence along the joint line of Lots Nos. 16 and 17 N 55-30 W 207.9 feet to the point of beginning.
