Know All Men by These Presents:

That I, Walter W. Goldsmith in the State aforesaid, in consideration of the sum of Forty-nine & 50/100 (\$49.50) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

L. T. Wright, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 52 of a subdivision known as Section "C", of Englewood Estates, as shown by a Plat thereof, dated December, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 13.

BEGINNING at an iron pin on Buffalo Drive at joint front corners of Lots No. 52 and 53 and running thence along the line of said Lot No. 53, S. 87-30 E. 200 feet to iron pin; thence S. 2-30 W. 75 feet to iron pin on Shasta Drive; thence along with said Shasta Drive, N. 87-30 W. 175 feet to iron pin at curve; thence along curve in a northeasterly direction 34.6 feet to iron pin on Buffalo Drive; thence with said Buffalo Drive N. 2-30 E. 50 feet to iron pin at point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than Five Thousand (\$5,000.00) Dollars.
2. No house is to be built closer than Fifty (50) feet to the street.
3. No temporary house is to be erected on said lot.

GRANTEE to pay taxes for 1953.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
