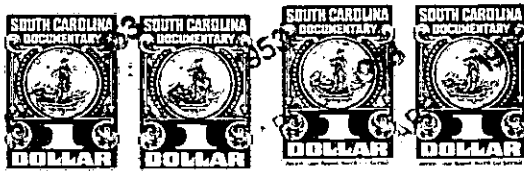

Know All Men by These Presents:

That We, Robert D. Edwards and Lillie H. Edwards, in the State aforesaid, in consideration of the sum of (\$6800.00) Six Thousand Eight Hundred and no/100-----DOLLARS.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert Arnold Alford, his heirs and assigns:

All that piece, parcel or lot of land, cityote, lying and being in the City of Greenville, South Carolina, County of Greenville, State of South Carolina, being known and designated as Lot No. 4, Block E, Fair Heights, as per plat thereof recorded in the R. H. S. Office for Greenville County, South Carolina, in Plat Book F, at page 257, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Bleckley Avenue, joint front corner of Lots Nos. 3 and 4, Block E, said iron pin being 150 feet from the Southwest corner of the intersection of Bleckley Avenue and Decatur Street, and running thence along the Southwesterly side of Bleckley Avenue, S. 31-20 W. 50 feet to an iron pin; thence N. 58-40 W. 150 feet to an iron pin; thence N. 31-20 E. 50 feet to an iron pin; thence S. 58-40 E. 150 feet to an iron pin, the point of beginning.

BEING the same property conveyed to the grantors herein by Lena B. Smith, by deed dated November 21, 1949, recorded in the R. H. S. Office for Greenville County, South Carolina, in Deeds Vol. 396, at page 371.

The grantee herein is to pay the 1953 taxes on the above described property.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
