POWER OF ATTORNEY

KNOW ALL MEN, that I, ETHELYN BERRY SMITH, wife of Major Lynn P. Smith, presently assigned to Headquarters Military Assistance Advisory Group, c/o American Embassy, Brussels, Belgium, now residing at 128 Avenue Franklin Roosevelt, Brussels, Belgium, do hereby constitute and appoint NELLE CHAPMAN BERRY, residing at 111 Marshall Avenue, Greenville, South Carolina, my true and lawful attorney, for me, and in my name.

(a) To endorse and collect checks payable to the order of the undersigned, granting to said attorney full power of substitution and revocation hereby ratifying and confirming all that said attorney or her substitute shall lawfully do or cause to be done by virtue hereof; and

(b) To ask, demand, sue for, recover, collect and receive all such sums of money, debts, accounts, interest, dividends, annuities and demands whatsoever, as now are, or hereafter shall become, due, owing, or payable, to me; and

(c) To make, execute and deliver acquittances, receipts, releases, or other discharges, therefor; and

(d) To purchase, receive, and take possession of all lands, tenements, and hereditaments, upon such terms, conditions and covenants as she may think proper; and

(e) To lease, bargain, transfer, convey, grant and mortgage all lands, tenements, and hereditaments, upon such terms, conditions and covenants as she may think proper; and

(f) To buy, sell, mortgage, hypothecate, and, in every way and manner, deal in and with, goods, wares, and merchandise, and choses in action; and

(g) To engage in, do and transact all and every kind of business that she may think proper; and

(h) To make, sign, execute, seal, acknowledge and deliver all such deeds, leases, and assignments of leases, covenants, indentures, agreements, hypothecations, bills of lading, bonds, notes, receipts, evidences of debt, releases, and satisfactions of mortgage, judgments, and other debts, and such other instruments whatsoever kind and nature, as may be necessary, or proper, in the premises.

And I, the said ETHELYN BERRY SMITH, hereby ratify all that my said attorney may lawfully do, or cause to be done, by virtue hereof.
