

- 6. 842 acres of land located near residence of J. Harvey Cleveland at Cleveland, S. C., being a portion of the property devised to J. Harvey Cleveland by Jessie F. Cleveland under the terms of his will filed for probate in 1905 and appearing in Apt. 81, File 10 in the Probate Court for Greenville County.
- 7. A tract of 171 3/4 acres on Devil's Fork of N. Saluda River in Cleveland Township being more fully described in deed from M. S. Poole to J. Harvey Cleveland dated November 25, 1925 and recorded in Volume 107 at Page 287 in the R. M. C. Office for Greenville County.
- 8. 99 acres more fully described in grant from the Sinking Fund of South Carolina and the Secretary of State for South Carolina to J. Harvey Cleveland dated January 3, 1908 and recorded in Volume P.P.P. at Page 168.
