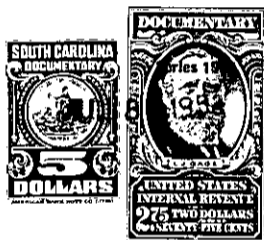
KNOW ALL MEN BY THESE PRESENTS That we, DONAVAN J. ALLEN AND GRACE M. ALLEN,
