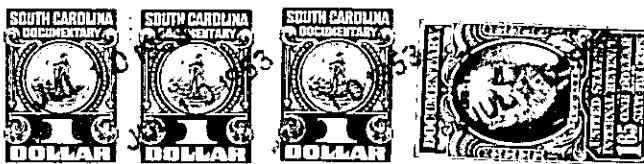
Lavinia Bramlett, her heirs and assigns,

N. Willis, Engineer, March 27, 1951, recorded in the R.M.C. Office for Greenville County in Flat Book "Z", at Page 149, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Keasler Street, joint front corner of Lots 18 and 20; thence along Keasler Street, S. 33-31 E. 216 feet to an iron pin, joint front corner of Lots 12 and 14; thence along common line of Lots 12 and 14, S. 56-29 W. 160 feet to an iron pin, joint rear corner of Lots 12 and 14; thence N. 33-31 W. 216 feet to an iron pin, joint rear corner of Lots 18 and 20; thence along the common line of Lots 18 and 20, N. 56-29 E. 160 feet to an iron pin, point of beginning.
