to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Champ Scott, his heirs and assigns forever:

All that lot of land in the City of Greenville, County of Greenville, State of South Carolina being known and designated as lot No. 68, Block F, as shown on the plat of University Heights, recorded in Flat Book BB at Page 21, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin in the Southwest side of Twin Brook Drive (formerly Drayton Drive) and running thence S. 56-37 W. 185 feet to iron pin, rear corner of lot 69; thence with line of said lot, N. 32-07 W. 100 feet to iron pin, rear corner of lot 71; thence with line of said lot, N. 56-37 E. 187.9 feet to iron pin in the Southwest side of Twin Brook Drive; thence with said Drive, S. 36-26 E. 100 feet to the point of beginning.

This property is conveyed subject to the following restrictions:

- 1. That this property shall be used for residential purposes only.
2. No house shall be constructed on said premises at a cost of less than \$10,000.00
3. The lot described above shall not be recut or resubdivided
4. Any construction on this lot shall be set back a total of 50 feet from the front lot line.
