all that piece, parcel or lot of land in Greenville Township, Greenville
County, State of South Carolina, being described as follows:

A lot in Poe Mill Village on Pinckney Street being designated as a
part of lot No. 19 of the Hammett land as shown on plat recorded in
the R. M. C. Office for Greenville County, S. C. in Deed Book HHH,
at Page 835 and having according to said plat the following courses
and distances:

BEGINNING on Pinckney Street at the corner of Lot No. 18 and running
thence with said street in an Easterly direction 100 feet to the cor-
ner lot Lot No. 20; thence with the line of Lot No. 20 in a Southerly
direction 95 feet to a 10-foot alley; thence with said alley in a
Westerly direction 100 feet to the line of Lot No. 18; thence along
the line of said lot in a Northerly direction 95 feet to the begin-
ning point.

Being the same lot conveyed to the Grantor herein by deed of the
Carolina Loan and Trust Company dated August 18, 1936, recorded
in the R. M. C. Office for Greenville County, S. C. in Deed Book
185, at Page 256.

ALSO:

All that certain piece, parcel or lot of land lying and being in
Greenville Township, Greenville County, State of South Carolina,
being known and designated as Lot No. 33 as shown on a plat of
Washington Heights, which plat is recorded in the R. M. C. Office
for Greenville County, S. C. in Plat Book F, at Page 54, and having
according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin 180.8 feet in a Southeasterly direction
from the Southeastern intersection of Anderson Street and Lincoln
Street at the joint corner of Lots 32 and 33 and running thence
along the line of Lincoln Street S. 43-25 E. 35 feet to an iron
pin joint corner of Lots Nos. 33 and 34; thence along the joint
line of said lots S. 46-35 W. 100 feet to the joint rear corner
of said lots; thence N. 43-25 W. 35 feet to an iron pin joint rear
corner of Lots 32 and 33; thence along the line of said lots N.
46-35 E. 100 feet to an iron pin the point of beginning.
