ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, being known and designated as Lot No. 23 of Parkvale, a plat of which is recorded in the RMC Office for Greenville County in Plat Book "K", at page 54 and being in Section "C" thereof and according to said plat, having the following metes and bounds, to wit:
