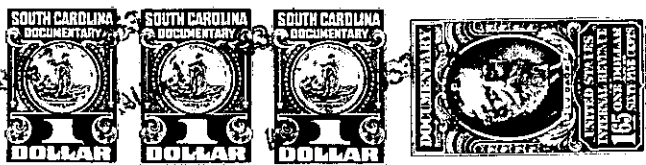

BEGINNING at an iron pin in the Northeast side of Twin Brook Drive (formerly Drayton Drive) joint front corner of lots 131 and 132, and running thence with joint line of said lots, N. 59-34 E. 203.9 feet to iron pin; thence N. 26-16 W. 100 feet to iron pin, rear corner of lot 130; thence with line of said lot, S. 59-34 W. 206.3 feet to iron pin in the Northeast side of Twin Brook Drive; thence with said Drive S. 30-26 E. 100 feet to the point of beginning.

This property is conveyed subject to the following restrictions:

- 1. That this property shall be used for residential purposes only.
2. No house shall be constructed on said premises at a cost of less than \$10,000.00
3. The lot described above shall not be recut or resubdivided
4. Any construction on this lot shall be set back a total of 50 feet from the front lot line.
