Know All Men by These Presents:

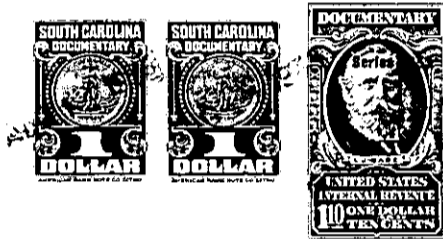

McKinney, and Nannie B. McKinney, their heirs and assigns forever:

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the eastern side of Elaine Avenue, being shown and designated as Lot No. 44 on plat of the property of William M.
