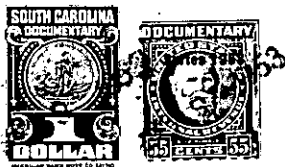
That I, Henry P. Willimon in the State aforesaid, in consideration of the sum of Four Hundred & 00/100 (\$400.00) DOLLARS,
