presents do grant, bargain, sell and release unto the said Gloria V. Sherman, her
heirs and assigns forever: One half of my one half undivided interest
in the following described property:

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, being a part of the same property conveyed
to me and Gloria V. Sherman, by D. U. Tilley and Leah C. Tilley,
by their deed dated January 16, 1953 and recorded in the R. M. C.
office for Greenville County and designated as Lot No. 76 Section
C as shown on Plat entitled "A subdivision for Woodside Mills,
Greenville, S. C. and being recorded in R. M. C. office for Green-
ville County in Plat Book W, pages 111-117, inclusive, and having
according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of East Seventh Street
at the joint front corner of Lots 77 and 76, and running thence
with the joint line of said lots, N. 7-29W. 119.1 feet to an iron
pin on the south side of a 12-foot alley; thence running along the
south side of said alley, N. 82-37E. 66 feet to an iron pin at the
joint corner of Lots 76 and 75; thence with the joint line of said
lots, S 7-29 E. 119 feet to an iron pin on the north side of East
Seventh Street at the joint front corner of Lots 76 and 75; thence
along the north side of East Seventh Street, S. 82-31 W. 66 feet to
