to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sara V. Collins, her heirs and assigns forever:

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known and designated as Tract No. 9, as shown on a plat of the property of Parkins Lake Development, prepared by Dalton & Neves, Registered Engineers, in January, 1954, to be recorded in the R. M. C. Office for Greenville County, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Parkins Lake Road, which iron pin is approximately 436.8 feet from the intersection of East Parkins Lake Road, and running thence N. 74-0 W. 556.9 feet to an iron pin, joint rear corner of Tract No. 7; thence S. 49-37 W. 246.7 feet to an iron pin, joint rear corner of Tract No. 10; thence along the line of Tract No. 10, S. 31-00 E. 1045 feet to an iron pin on the Western side of Parkins Lake Road; thence along the Western side of the said road, N. 14-51 E. 146.8 feet to an iron pin; thence N. 25-54 E. 122 feet to an iron pin; thence N. 44-13 E. 123.2 feet to an iron pin; thence N. 51-37 E. 184.5 feet to an iron pin; thence N. 18-31 E. 42 feet to an iron pin; thence N. 25-49 W. 232.6 feet to an iron pin; thence N. 14-22 W. 204.2 feet to an iron pin, the point of beginning.
