All that certain piece, parcel or lot of land in the State and County aforesaid known and designated as Lot No. 12 on plat of Bellwood Estates by Dalton & Neves, dated May 1950 and having, according to said plat the following courses and distances, to-wit:

BEGINNING at an iron pin on the eastern side of Rutherford Road at the joint front corner of lot Nos. 11 and 12 and running thence with the joint line of said lots N. 59-30 W. 202.2 feet to a point; thence with the joint rear line of lot Nos. 12 and 29, N. 30-30 E. 70 feet to a point, joint rear corner of lots Nos. 12 and 13; thence with the joint line of said lots S. 59-30 E. 197.2 feet to a point on Rutherford Road; thence with Rutherford Road S. 25-50 W. 70.23 feet to the beginning corner.

This conveyance is subject to the following restrictions, covenants and conditions, to-wit:

That the said lands shall not be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence costing less than \$5,000.00 shall be erected on lots fronting on Old Rutherford Rd. and Oxford Drive; no residence costing less than \$3,500.00 shall be erected on said lot nearer than 25 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks. This property sold subject to right-of-ways to Duke Power Company, granted or to be granted, for residence power line.

Grantee to pay 1954 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
