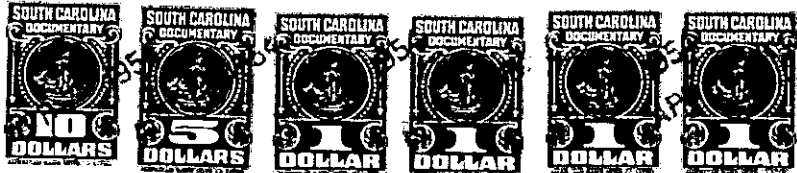

BEGINNING at an iron pin on the northeast side of North Estate Drive, at joint front corner of Lots 47 and 48 and running thence along the line of Lot 47, N. 61-35 E. 132.5 feet to an iron pin; thence S. 18-0 E. 86 feet to an iron pin; thence S. 65-15 W. 130 feet to an iron pin on the northeast side of North Estate Drive; thence with the northeast side of North Estate Drive, N. 18-30 W. 75 feet to the beginning corner.
