W. F. White, his heirs and assigns, all my interest in the property belonging to my deceased mother, Lillian White, being described as follows:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, about 2 1/2 miles west of Greenville County Court House, on the western side of Georgia Avenue, known and designated as Lot No. 21 on plat of property of Julia D. Charles, recorded in Plat Book E, Page 259, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Georgia Avenue, corner of Lot No. 19 (which pin is 749.9 feet from Easley Bridge Road), and running thence along the western side of Georgia Avenue, N. 9-30 W. 80.9 feet to iron pin, corner of lot No. 23; thence with line of said lot, S. 71 W. 200 feet to iron pin, corner of lot No. 20; thence with line of said Lot N. 71-30 E. 200 feet to the beginning corner.
