

KNOW ALL MEN BY THESE PRESENTS: That, I, CLAUDE B. ILER, JR.,  
a legal resident of Greenville State of South Carolina  
United States of America, now in the military service as a Second Lieutenant  
(Army Serial No. 04 012 783) in the Army of the United States, and anticipating  
that I may be required to go overseas in said military service, have made, con-  
stituted and appointed, and by these presents do make, constitute and appoint  
my wife, JULIANNE H. ILER, whose address is Greenville, South Carolina,

my true and lawful attorney to act in, manage, and conduct  
all my estate and all my affairs, and for that purpose for me and in my name,  
place, and stead, and for my use and benefit, and as my act and deed, to do and  
execute, or to concur with persons jointly interested with myself therein in the  
doing or executing of, all or any of the following acts, deeds and things, that  
is to say:

- (1) To buy, receive, lease, accept, or otherwise acquire; to sell, convey, mortgage, hypothecate, pledge, quitclaim or otherwise encumber or dispose of; or to contract or agree for the acquisition, disposal, or encumbrance of; any property whatsoever or any custody, possession, interest, or right therein, upon such terms, considerations and conditions as my said attorney shall think proper;
- (2) To take, hold, possess, invest, lease, or let, or otherwise manage any or all of my property or any interest therein; to eject, remove, or relieve tenants or other persons from and recover possession of, such property by all lawful means; and to maintain, protect, preserve, insure, remove, store, transport, repair, build on, raze, rebuild, alter, modify, or improve the same or any part thereof;
- (3) To make, do, and transact all and every kind of business of what nature or kind soever, including the receipt, recovery, collection, payment, compromise, settlement, and adjustment of all accounts, legacies, bequests, interests, dividends, annuities, demands, debts, taxes and obligations, or any rebate, refund or discount thereon, which may now or hereafter be due, owing, or payable, by me or to me;
- (4) To make, indorse, accept, receive, sign, seal, execute, acknowledge, and deliver deeds, assignments, agreements, certificates, hypothecations, checks, notes, vouchers, receipts, and such other instruments in writing of whatever kind and nature as may be necessary, convenient, or proper in the premises;
- (5) To deposit and withdraw for the purposes hereof, in either my said attorney's name or jointly in both our names, in or from any banking institution, any funds, negotiable paper, or moneys which may come into my said attorney's hands as such attorney or which I now or hereafter may have on deposit or be entitled to;
- (6) To contract loans and to borrow any sums of money in my name and upon such terms as my said attorney shall see fit, and to pledge or give as security therefor any or all of my said property;
- (7) To institute, prosecute, defend, compromise, arbitrate, and dispose of legal, equitable, or administrative hearings, actions, suits, attachments, arrests, distresses or other proceedings, or otherwise engage in litigation in connection with the premises;
- (8) To act as my attorney or proxy in respect to any stocks, shares, bonds, or other investments, rights, or interests, I may now or hereafter hold;
- (9) To occupy, expend or use all or any part of my said estate as now or hereafter constituted for the education, care, support, maintenance and benefit of my son, CLAUDE B. ILER, III, and to appoint and remove at pleasure any substitute for, or agent of my said attorney, in respect to all or any of the matters or things herein mentioned and upon such terms as my attorney shall think fit (except that the authority hereinabove granted in paragraph numbered nine shall not be exercised in behalf of, or enure to the benefit of, anyone except said son, CLAUDE B. ILER, III);
- (11) To execute and deliver vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States including but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law and Army Regulations;
- (12) To execute, acknowledge, present, and prosecute any claim or demand whatsoever on or against the government of the United States, of any sovereign state or authority, or of any political subdivision or instrumentality thereof;
- (13) To receive, endorse, and collect checks payable to the order of the undersigned drawn on the Treasurer or other fiscal officer or depository of the United States, of any sovereign state or authority, or any political subdivision or instrumentality thereof;
- (14) To prepare, execute, and file income and other tax returns, and other governmental reports, applications, requests and documents;
- (15) To take possession, and order the removal and shipment, of any of my property from any post, warehouse, depot, dock, or other place of storage or safekeeping, governmental or private; and to execute and deliver any release, voucher, receipt, shipping ticket, certificate, or other instrument necessary or convenient for such purpose.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter, and thing whatsoever in and about my estate, property, and affairs as fully and effectually to all intents and purposes as I might or could do in my own proper person if personally present,
