All those two pieces, parcels or lots of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina being known and designated as Lots Nos. 59 and 61 on a plat of Property of Pecan Terrace recorded in the R. M. C. Office for Greenville County in Plat Book GG, page 9 and being briefly described as follows to-wit:

Lot No. 59 fronts 110 feet on the north side of Rocky Knoll Drive and has a rear line of 120.8 feet on the north side of Rocky Knoll Drive, a Southern line of 89.1 feet and a northern line of 136.5 feet.

Lot No. 61 fronts on the west side of Mayflower Avenue having a frontage of 95 feet thereon, a rear line of 101 feet, a southern line of 95 feet and a northern line of 129.2 feet, all of which are more fully shown on the above referred to plat.

These lots are conveyed subject to the building restrictions as set forth on the above plat and as recorded in the R. M. C. Office for Greenville County in Deed Book 477, page 291. (Any fuel or oil tank shall be enclosed in the building structure or placed underground.)

The above is part of the property conveyed to me by E. Imman, Master by two deeds, one recorded in the R. M. C. Office for Greenville County in Deed Book 464, page 392 and the other being recorded in Deed Book 140, page 108.
