All that certain piece, parcel or lot of land lying and being on the Westerly side of Old U. S. Highway No. 25 and across said Highway from Donaldson Air Force Base, near the City of Greenville, S. C., being shown as the property of George S. Rainey on a plat thereof made by J. Mac Richardson, dated April, 1954, and recorded in the RMC Office for Greenville County, S. C. in Plat Book "HH", page 75, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Old U. S. Highway No. 25, at a point 345 feet North of the corner of property formerly belonging to George S. Rainey and the Shockley property, said pin also being the joint corner of the property of George S. Rainey and the property of John R. New, and running thence along the line of the New property N 80-50 W 210 feet to an iron pin; thence continuing with the line of the New property S 1-45 E 100 feet to an iron pin, joint corner of the property of New, Childers, Foster and Rainey; thence with the line of the Foster property N 80-50 W 343.7 feet to a nail in a tie in the center line of the railroad spur track running to the Air Base; thence along the center line of said spur track N 3-10 E 270.7 feet to a nail in a tie, joint rear corner of the property of Rainey and property belonging to Goldsmith and Kilgore; thence along the joint line of the Goldsmith and Kilgore property S 87-55 E 521 feet to an iron pin on the Westerly side of Old U. S. Highway No. 25; thence along the Westerly side of said Highway S 1-45 E 240 feet to the point of beginning, and containing 3.33 acres according to said plat.
