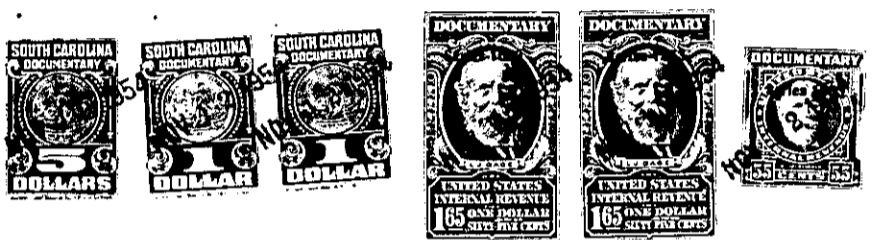
That May S. Welch OLLIE FARNSWORTH in the State aforesaid,
