All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being lot No. 17, and 15 feet off the southwestern side of lot No. 18 on plat of L. A. Moseley recorded in plat book J page 239 of the R. M. C. Office for Greenville County, S. C., and having according to a recent survey made January 1956 by R. W. Dalton, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the northwest side of Burgess Avenue (formerly Charles Street), the joint front corner of Lots 16 & 17; thence with the northwest side of said Burgess Avenue N. 43-15 E. 75 feet to an iron pin; thence N. 46-45 W. 145 feet to an iron pin in the rear line of Lot No. 4; thence with the rear line of lots 4 and 5, S. 43-15 W. 75 feet to an iron pin corner of Lot No. 16; thence with the line of said lot S. 45-45 E. 145 feet to an iron pin on the northwest side of Burgess Avenue, the point of beginning.
