All those pieces, parcels or lots of land in Chick Springs Township, Greenville County State of South Carolina, situate, lying and being on the North side of Lee Road, and being known and designated as Lots Nos. 53, 54 and 55 of Block "D" of Buena Vista, as shown on a Plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "W" pages 11 and 29, and being described together according to said plat as follows
