in consideration of the sum of THREE THOUSAND AND NO/100 (\$3,000.00) ----- DOLLARS, to the grantor(s) in hand paid at and before the scaling of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JOHN F. RUTH, His Heirs and Assigns Forever:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, at the corner of McDaniel Avenue and Carroll Street, and being the major portion of Lot 19, as shown on plat recorded in the R.M.C. Office, Greenville County, South Carolina, in Plat Book T, page 21, and a small portion of Lot 20, as shown on plat recorded in said R.M.C. Office, in Plat Book LL, at page 163, and having the following metes and bounds, to-wit:

BEGINNING at the southeast corner of the junction of McDaniel Avenue and Carrol Street (now McDaniel Court); thence along Carrol Street, S. 74-45 E. 180 feet to corner of Lot 18; thence S. 15-15 W. 81 feet to new corner in rear line of Lot 19; thence N. 77-17 W. 114.0 along line of property of Seline D. Ruth; thence continuing along her line, N. 77-17 W. 57.0 feet to an iron pin in line of Lot 20 on McDaniel Avenue; thence along McDaniel Avenue, N. 9-25 E. 2.0 feet to an iron pin, front corner of lots 19 and 20; thence continuing along McDaniel Avenue, N. 9-25 E. 89.2 feet to point of beginning.

Being all of the property conveyed to Herbert B. Drake by deed recorded in Book 572, page 417, and the small segment of Lot 20 conveyed to H. B. Drake by deed recorded in Deed Book 568, page 499, said R.M.C. Office. It was intended to convey all of the above property to Herbert B. Drake, Jr. by the first mentioned deed, but since some question has arisen as to whether the small portion of Lot 20, known as Segment A, was so conveyed by H. B. Drake, the latter now joins in the execution of this instrument to convey such interest as he may have in said Segment A to the Grantee herein.
