That I, Jesse M. Ray in the State aforesaid, in consideration of the sum of Six Hundred Eighty-six (\$686.00)----- DOLLARS,

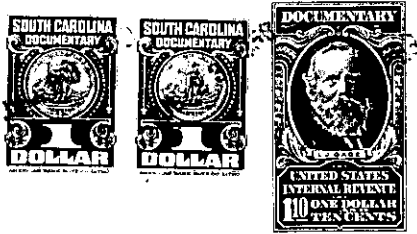
