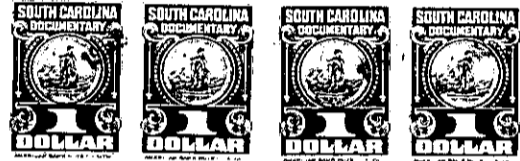
BEGINNING at an iron pin on the West side of Waddell Road at joint front corner of Lots 7 and 8 and running thence with the line of Lot 8, S. 62-02 W., 208 feet to an iron pin; thence S. 41-10 E., 65 feet to an iron pin; thence N. 72-02 E., 306.9 feet to an iron pin on the West side of Waddell Road; thence along the West side of Waddell Road N. 33-56 W., 100 feet to the beginning corner.

THIS is a portion of that property conveyed to the Grantors herein by deed of Berrice B. Fair, et al, dated November 10, 1936, recorded in the RMC Office for Greenville County, S. C., in Deed Book 191, page 27.

THIS property is conveyed subject to the following restrictions:

- (1) This property shall be used for single family residential purposes only.
- (2) No dwelling shall be constructed on said lot nearer than 35 feet to the front lot line or nearer than 10 feet to any side lot line.
- (3) No dwelling shall be constructed on said property having an area of less than 1000 square feet on the ground floor.
