## CHARTER

BY THE SECRETARY OF STATE

WHEREAS,

signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is THE KAYNEE COMPANY

THIRD: That the principal place of business is c/o Price & Poag, Lawyers Building GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is the buying, selling and manufacturing of garments for human requirements, including but not restricted to, mens and boys shirts, pajamas, jackets, trousers, robes, swim wear, knit wear and sports wear; and the purchase and sale of real estate.

FIFTH: That the amount of the capital stock is One Hundred Thousand (\$100,000.00)----- Dollars payable Fifty thousand (\$50,000.00) subscribed; Twenty thousand (\$20,000.00) Dollars paid in.

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in The Greenville News

a newspaper published in the County of

Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
