

Angelos Chatos, Jimmy Chatos and Andreas Petratos, their heirs and assigns: All those pieces, parcels and lots of land situate, lying and being in Greenville County, South Carolina, being shown and designated as Lots Nos. 4, 5 and 6 on plat of property of grantor, recorded in Plat Book "EE", Page 22, and according to said plat having the following metes and bounds, to wit:

BEGINNING at a point on the southwest side of New Buncombe Road, (Poinsett Highway), at joint front corner of lots 3 and 4 and running thence with the line of said lots S. 50-57 W., 289.7 feet; thence S. 39-12 E., 300 feet; thence N. 50-57 E., 289 feet to a point on the southwest side of New Buncombe Road; thence with said road N. 39-30 W., 300 feet to the point of beginning.
