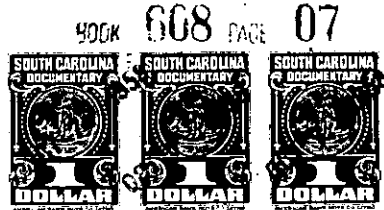

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
THOMAS LEYLAND MACHINERY COMPANY, INC.

All that piece, parcel or tract of land, containing .47 acre, more or less, situate, lying and being on the Northeastern side of U. S. Highway No. 276 (Old), approximately one mile north of the Town of Simpsonville, Austin Township, County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 4 as shown on a plat prepared by W. J. Riddle, Surveyor, dated February, 1948, entitled "Property of R. H. Martin," and recorded in the R. M. C. Office for Greenville County in Plat Book U at page 27; being known and designated as Tract "D-2" as shown on a more recent plat prepared by Piedmont Engineering Service, dated September 1958, entitled "Survey for Thomas Leyland Machinery Co., Inc." and recorded in the R. M. C. Office for Greenville County in Plat Book EE at page 192 and having, according to the last mentioned plat, the following metes and bounds:

BEGINNING at a point in the center of U. S. Highway No. 276 (Old) and running thence with the line of Tract "C" N. 39-0 E. 200.2 feet to a point; thence with the line of Tract "D-1" S. 47-03 E. 112 feet, more or less, to a point in the line of other property of the grantor; thence with the line of said other property of the grantor, S. 42-57 W. 200 feet to a point in the center of U. S. Highway No. 276 (Old); thence with the center of U. S. Highway No. 276 (Old) N. 47-03 W. 100 feet to the point of beginning.

This is a portion of the property conveyed to the grantor herein by deed of T. M. Wright dated March 19, 1954 and recorded in the R. M. C. Office for Greenville County, South Carolina in Deed Book 496 at page 233.
