

all that piece, parcel or lot of land in Fairview

Township, Greenville

County, State of South Carolina in the Town of Fountain Inn, known and designated as Lot No. 21 on a Plat of the Weathers property prepared by C. O. Riddle, Surveyor, dated September 1, 1953, and having according to said Plat the following courses and distances, to-wit:

EEGINNING at an iron pin in the northwestern edge of a new street (extension of Gault Street) and running thence N. 50 W. twenty-three and eight tenths (23.8) feet to an iron pin; thence N. 1-31 E. One Hundred Twenty-Nine (129) feet to an iron pink near road; thence N. 70-46 E. One Hundred Sixty-Two (162) feet to an iron pin in edge of road, intersection of new street (extension of Gault Street) with said road; thence with said new street S. 5-41 W. Thirty-Five and four-tenths (35.4) feet to an iron pin; thence continuing with edge of said new street S. 32-48 W. One Hundred (100) feet to an iron pin; thence S. 45-54 W. One Hundred Twelve (112) feet to an iron pin, the point of beginning and bounded by land of J. T. Gault, Road, and New Street (Extension of Gault Street).

This being the same property as conveyed to the Grantors by deed recorded in Deed Book 516, Page 237 in the R. M. C. Office for Green-ville County, less a small portion conveyed out by Deed to A. E. Green, Mayor of the Town of Fountain Inn dated September, 1955, and recorded in the R. M. C. Office for Greenville County. However, this part as conveyed out by the Grantors herein has been re-conveyed to the Grantee herein under separate Deed from A. E. Green, Mayor of the Town of Fountain Inn, Et Al and to be recorded in the R. M. C. Office for Greenville County.

ALSO, all that piece, parcel or lot of land in Fairview Township, Green-ville County, State of South Carolina in the Town of Fountain Inn on the west side of Woodvale Avenue, according to plat of the property of Floyd Weathers made on September 1, 1953 by O. C. Riddle and recorded in the R. M. C. Office for Greenville County and being more fully described, to-wit:
