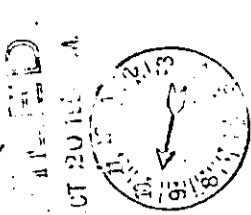

Raymond Rutledge, his heirs and assigns forever:

All that certain piece, parcel or lot of land, situate, lying and being in Highland Township, said State and County, on the North side of Few's Chapel Road, approximately .25 mile East of Few's Chapel, being shown and designated as the greater part of Lot No. 2 on a plat of property prepared for W. H. Campbell by J. Q. Bruce, Surveyor, April 19, 1957, recorded in Plat Book Vol. NN at page 63, and having the following metes and bounds, to-wit:

BEGINNING on an iron pin, joint rear corner lots Nos. 1 and 2, and running thence with the line of lot No. 1, N. 76-35 E. 203 feet to a stake or iron pin on the Eastern side of said road S. 8-30 E. 150 feet to a stake or iron pin; thence a new line, S. 76-35 W. 173 feet more or less, to an iron pin on line of W. H. Campbell; thence with the line of W. H. Campbell, N. 18-42 W. 150 feet to the point of beginning.
