That I, WILLIAM R. TIMMONS, JR., in consideration of the sum of Nineteen Hundred Seventy and no/100----- in the State aforesaid, DOLLARS,

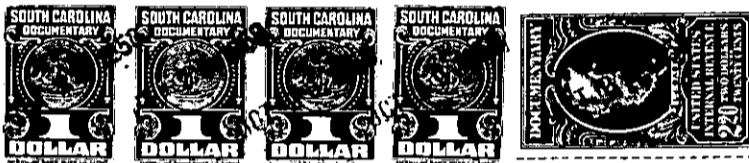
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JOHN R. RODGERS, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 60 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Shadydale Court at the joint corner of Lots 59 and 60 and running thence N 20-04 W 202 feet to a point at the joint rear corner of Lots 59 and 60; thence N 71-20 E 125.9 feet to a point on the Western side of McSwain Drive at the joint corner of Lots 60 and 64; thence with the Western side of McSwain Drive S 22-23 E 237.7 feet to a point; thence following the curvature of the Northwestern intersection of Shadydale Court with McSwain Drive (the chord of which is S 36-43 W 26.1 feet) to a point; thence with the Northern side of Shadydale Court N 84-34 W 119.3 feet to a point; thence continuing with the Northern side of Shadydale Court S 87-22 W 5.9 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1958 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
