"BEGINNING at an iron pin on the northwestern side of White Horse Road, thence down the center of an unpaved road N 60-24 W. 279.5 ft; to a iron pin in bend of road; thence continuing N 33-35 W. 183.1 ft. to an iron pin; thence along the line of "Parcel A" S 85-56 E. 532.2 ft. to an iron pin on the north western side of White Horse Road; thence along that side of White Horse Road S 34-15 W. 82.3 ft. to an iron pin; thence continuing S 36-30 W 104 ft. to an iron pin; thence continuing S 37-58 W. 127.4 ft. to the beginning, containing 1.91 acres, more or less. This conveyance is made subject to the following easements and restrictive covenants which are intended by these parties to run with the land and be binding upon their heirs and assigns for a period of ten (10) years: (1) This parcel shall not be recut into more than two lots; provided, however, should the property Northwest of this parcel be sub-divided and the unpaved road be improved to give access thereto then the rear portion of this parcel may be cut into a third lot fronting on the improved road. (2) With the exception of the aforesaid third lot all lots shall face on the White Horse Road. (3) No house shall be constructed on the portion adjoining the Williams property, or upon the rear portion of this parcel unless the plans and specifications are first approved by J. E. Williams; provided, however, should these grantees themselves desire to build their residence on the southeastern portion, it is agreed that the plans now contemplated are approved by the grantor. (4) No lot shall be used except for residential purposes.
