All that piece, parcel or lot of land in Welcome Township, Greenville County, State of South Carolina, being known and designated as Lot number ten (10) on plat of Cochran Heights, property of Mrs. N. C. Cochran Estate, prepared by C. O. Riddle, Surveyor in November 1952, and thereafter revised on August 30, 1954, the original plat being of record in the RMC Office for Greenville County, South Carolina, in Plat Book HH at page 13, the said lot having the following metes and bounds, to wit:
