Know All Men by These Presents:

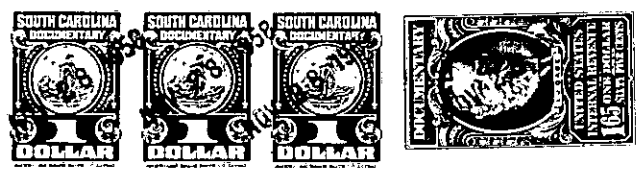

TIMMONS, JR., in the State aforesaid, in consideration of the sum of ONE THOUSAND FOUR HUNDRED AND NO/100--(\$1,400.00)--DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 11 of the property of W. T. Patrick and William R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 131, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Lawnview Court at the joint front corner of Lots 10 and 11 and running thence N 34-20 W 182.7 feet to a point at the joint rear corner of Lots 10 and 11; thence S 55-40 W 80 feet to a point at the joint rear corner of Lots 11 and 12; thence S 34-20 E 182.7 feet to a point on the Northwestern side of Lawnview Court at the joint front corner of Lots 11 and 12; thence with the Northwestern side of Lawnview Court N 55-40 E 80 feet to the point of beginning.
