All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in the City of Greenville, being known and designated as the greater portion of lot # 85, and a 10 foot strip of lot # 86, of a subdivision of Dixie Heights, as shown on plat recorded In Plat Book H at Page 46, and also being shown as 50 feet of lot 85 of a resubdivision of a portion of Dixie Heights, made by John A.
