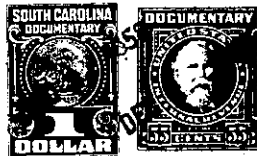

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Furman L. Hall and Norma Hall, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 99, on a Plat of Wynette Estates by Pickell & Pickell, Engineers, dated July 24, 1953, recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 37, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Willimon Drive, joint front corners of Lots Nos. 98 and 99 and running thence along the line of said lots, S. 63-58 W. 173.7 feet to iron pin; thence running N. 26-02 W. 80 feet to iron pin rear corner of Lot 100; thence running with line of said lot, N. 63-58 E. 180 feet to iron pin on Willimon Drive; thence running with said Drive, S. 26-02 E. 40 feet to iron pin; thence running, S. 17-05 E. 40.5 feet to iron pin at point of beginning.
