That T. H. Stokes and Roy Farnham in the State aforesaid, in consideration of the sum of Five Hundred and no/100 DOLLARS,

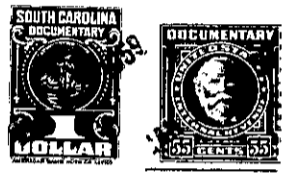
