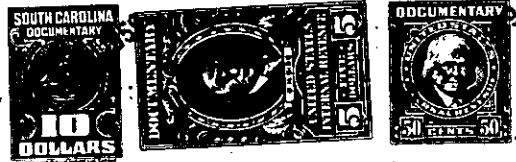

Alvin Gilreath, his heirs and assigns forever:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Chick Springs Township, on the southern side of Sweetbrier Road, being shown as Lot 6 on a plat of Section 2 of Lake Forest Heights recorded in Plat Book PP at Page 150, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Sweetbrier Road at front corner of Lots 5 and 6 and running thence with the line of said lots S. 5-22 E. 188.4 feet to an iron pin; thence N. 85-39 E. 139.5 feet to iron pin in line of Lot 7; thence with the line of Lot 7 N. 19-38 W. 201.2 feet to an iron pin on Sweetbrier Road; thence with said road S. 82-03 W. 90 feet to the point of beginning.
