NOW, Therefore, Know all Men by these Presents, that I, ~~R. M. C.~~ in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release

unto the said United States of America and its assigns all the right, title and interests of said defendants in and to an undivided one-sixth (1/6th) of the following described property:

ALL that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, designated as Lot 8, of Block 2, in the City Block Book, page 17, of Greenville, South Carolina, and having the following metes and bounds:

BEGINNING at a stake on the Northern side of West Washington Street, at the corner of the Lot sometimes referred to formerly as the Gridley Lot (now the Elias Howard Lot), and running thence S. 49 E. 55 feet, more or less, to a stake on the Lot sometimes referred to formerly as the Taylor Lot (now the E. S. Harper Lot); thence N. 41 1/2 E. 165 feet, more or less, to a stake at the corner of said Taylor (now E. S.
