

BEGINNING at an iron pin on the east side of Buffalo Drive, joint front corners of lots 55 and 56 and running N. 2-30 E. 75 feet to an iron pin on Buffalo Drive, joint front corners of lots 56 and 57; thence with the line of lots 56 and 57 S. 87-30 E. 200 feet to an iron pin at joint rear corners of lots 57 and 56; thence with the rear line of lot 56 S. 2-30 W. 75 feet to an iron pin, joint rear corners of lots 56 and 55; thence with the line of lots 56 and 55 N. 87-30 W. 200 feet to an iron pin on Buffalo Drive, the point of beginning.

No residence shall be erected at a cost of less than \$5000.00. No residence shall be erected unless said lot have 50 feet or more frontage, and no nearer than 50 feet to the front line. No temporary dwelling is to be erected on said lot.
