M. C. Office for Greenville County in Plat Book A, pages 337-341, and being more particularly described as follows:

BEGINNING at an iron pin on the South side of Croft Street, being 391 feet from the Southeast corner of Wilton and Croft Street, and running thence S. 1-41 W. 200 feet more or less to an alley; thence with said alley S. 83-13 E. 65-1/2 feet to an iron pin; thence N. 1-41 E. 200 feet, more or less, to an iron pin on the South side of Croft Street; thence with Croft Street No. 83-13 W. 65-1/2 feet to the beginning corner.
