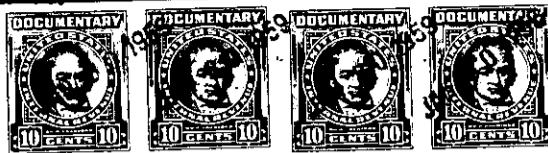

Know All Men by These Presents:

That I, M. G. PROFFITT in the State aforesaid,  
in consideration of the sum of Nine Thousand Four Hundred Thirty-five and 26/100--- DOLLARS,  
AND ASSUMPTION OF MORTGAGE REFERRED TO BELOW  
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM DEWEY FRIDDLE, JR., his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the East side of Proffitt Drive, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 25 on Plat of Liberty Park, made by Piedmont Engineering Service, March, 1955, recorded in the RMC Office for Greenville County, S. C., in Plat Book "EE", page 145, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of Proffitt Drive at joint front corner of Lots 24 and 25 and running thence with the line of Lot 24, S. 89-17 E., 163.2 feet to an iron pin; thence S. 6-00 E., 120.6 feet to an iron pin; thence with the line of Lot 26, N. 89-17 W., 176.7 feet to an iron pin on the East side of Proffitt Drive; thence with the East side of Proffitt Drive, N. 0-43 E., 120 feet to the beginning corner.

THIS is a portion of the property conveyed to me by deed of J. H. Sitton, et al, recorded in the RMC Office for Greenville County, S. C., in Deed Book 540, page 161.

THE Grantee herein assumes and agrees to pay the balance due on that mortgage in the original amount of \$24,000.00 given by M. G. Proffitt to First Federal Savings and Loan Association of Greenville, S. C., on April 21, 1958, recorded in the RMC Office for Greenville County, S. C., in Mortgage Book 745, page 171.

GRANTEE to pay 1959 taxes.

Proffitt Drive is now known as Proffitt Circle.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

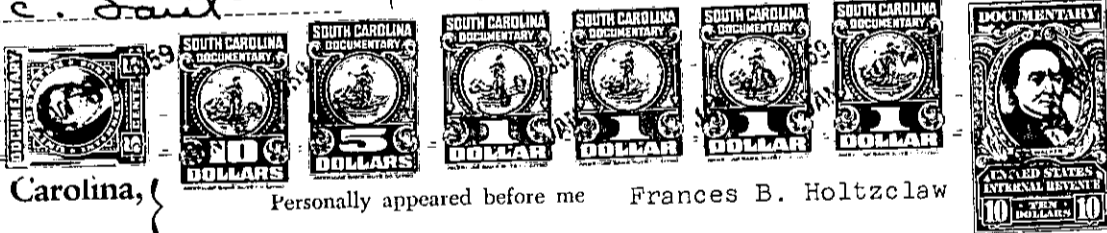
