Charter of State of South Carolina to Lasley Lumber Co.

Whereas, T.L. Bivens, J. AcD. Bruce & A.F. Day did on the 10th day of Dec. 1913 file with the Secretary of State a written Declaration, signed by themselves, setting forth:

First: The names and residences of the said petitioners to be as above given.

Second: The name of the proposed corporation be that of Easley Lumber Co.

Third: The principal place of business of the corporation will be Easley, S.C.

Fourth: The general purpose of the corporation, and the nature of business it proposes to do, to buy building material, machinery, live stock, and real estate and to operate a planing and saw mill.

Fifth: The amount of the capital stock to be Sixty four hundred Dollars, and the number of shares into which the same is to be divided to be Sixty four of the par value of One hundred Dollars each.
